ITINERARY

Day 1 – Depart USA from Newark to Tel Aviv.

Dinner and breakfast are served on board the flight.

Day 2 – Arrival Tel Aviv – Tiberias

We arrive Tel Aviv, we meet our English speaking Christian guide and board our deluxe motor coach to Tiberias for dinner and overnight. (D)

Day 3 – Sea of Galilee

We board a boat for some reflective sailing on the Sea of Galilee followed by visit of the ancient boat (Boat and Entrance Included), and then ascend to the Mount of Beatitudes to gain a panoramic vista of the area around the Sea. We travel to Capernaum to visit the ancient synagogue and the House of Peter. We then travel along the shore to Tabgha, the Church of the Multiplication, where Jesus fed the multitudes, the Church of Peter's Primacy, where Jesus commissioned Peter to shepherd his church. We celebrate Mass in this peaceful spot on the shores of the Sea of Galilee. For lunch we enjoy a meal of the same kind of fish caught by Peter (Lunch Included). This afternoon we stop at the Valley of the Doves along the gospel trail that Jesus would have walked followed a visit to Magdala (Entrance Included), hometown of Mary Magdalene, where we see the ruins of the 1st century Synagogue and the famous carved Menorah. Then we visit the ruins of the town and the newly consecrated church with its Boat shaped altar. Dinner and overnight in Tiberias (B,L,D)

Day 4 – Nazareth – Sepphoris - Cana – Haifa

We celebrate Mass at the Basilica of the Annunciation, pray at the grotto where the angel appeared to Mary, and see the Church of St. Joseph and its excavations. Other sites of the city include Mary's Well, the Synagogue Church, St. Gabriel Church, and Chapel of Mary's Fright. We then enjoy a one-hour multi-media presentation at Mary of Nazareth International Center (Entrance Included). We travel to the nearby archaeological park at Sepphoris and see St. Ann Convent (Entrance Included). We then travel to the church at Cana, the site of Jesus' first miracle, where couples may re-new their marriage vows. Enjoy a talk tonight by Rebecca Jackson "The Jewishness of Mary"! Dinner and overnight at Tiberias (B,L,D)

Day 5- Caesarea- Acco- Haifa- Mt. Carmel


We journey to the ancient port of Caesarea Maritime from where St. Paul set out on his first Missionary Journey. Our next stop is the busy port city of Haifa to see Mount Carmel, the Stella Maris Church dedicated to Our Lady Star of the Sea where we celebrate Mass and the Cave of Elijah. In the afternoon we visit the Acco to see the Crusader city and tunnels. Early dinner is in Acco. Overnight Tiberias. (B,L,D)

Day 6 – Mt Tabor – Bet Arabah – Jericho – Jerusalem

We drive the winding ascent to the top of Mount Tabor (Entrance Included) for a view of the Valley of Jezreel. We visit the Church of the Transfiguration with its radiant mosaic and chapels of Moses and Elijah. We then travel southward along the Jordan valley to Bet Arabah where the Israelites crossed into the Promised Land, it is also where Elijah the prophet was taken into Heaven and where Our Lord was Baptized. Lunch on your own. After lunch visit Jericho to include Tel Jericho (Entrance Included) where Jericho stood at the time of Joshua and see Mt of Temptation, New Testament Jericho and Sycamore Tree. Start our ascent to Jerusalem where upon arrival we enjoy a view from Mt Scopus and celebrate a Genesis Welcome into the City. Transfer to Jerusalem to the Pontifical Institute Notre Dame Center for dinner and overnight (B,D)

Day 7 – Bethlehem – Shepherd Field – Sharing the Bread

We visit the Basilica of the Nativity in Bethlehem and the grotto of Jesus' birth. We celebrate Mass at St. Catherine Church. And then travel to Beit Sahour 'Migdal Eder' and visit the chapel in Shepherd's Field. Lunch on your own. On to visit Cremisan Winery for a wine tasting (wine tasting Included). Time will be allotted for shopping in Bethlehem at the Kando Christian family store, where we see one of the original Dead Sea Scroll Jars. Sharing the Bread dinner: we have a unique cultural experience tonight as we share a meal with local Christian families of Bethlehem. Return to Jerusalem for overnight at the Notre Dame de Jerusalem. (B, Special Meal)



Colorado Springs is the home of a scientific team that has collectively performed in excess of 100 person-years of scientific research on the Shroud of Turin. Rebecca Jackson is a longtime convert to Christianity from Orthodox Judaism. She runs the TSC Exhibit Presentation Center and also conducts her own research into the First Century Jewish aspects of the Shroud, a field of scholarship that is of great importance for authenticity.

Day 8 – Temple Mt. – St Ann’s – Israeli Museum – Ein Kerem – Shroud of Turin Exhibition and Lecture

Start the day with visit to the Temple Mount. where Ibrahim went to Sacrifice Isaac at the foundation stone where The Temple of Jerusalem stood. Carry on to visit the Pools of Bethesda (Entrance Included) where Jesus healed the paralytic and the nearby St Ann’s Church birth place of the Virgin Mary. We carry on to the Israeli Museum (Entrance Included) visit the Shrine of the Book and the nearby Model city of Jerusalem on scale of 1:50 showing Jerusalem as it looked in the 1st century AD. Lunch on your own. This afternoon we visit Ein Kerem to include the birthplace of St John the Baptist and church of the visitation where we celebrate Mass. Tonight we are fortunate to have a private visit to the Shroud of Turin exhibition at the Notre Dame of Jerusalem Center. Tonight’s talk by John Jackson will be “ The Shroud, Holy Thursday, Good Friday and Easter Sunday”. Return to Hotel for dinner and overnight. (B,D)

Day 9 – Bethany – Masada – Qumran – Dead Sea

This morning we depart for Bethany hometown of Mary, Martha and Lazarus where we celebrate mass and visit the empty tomb of Lazarus (Entrance Included). Proceed along the Judean Wilderness to Masada (Entrance Included) the Zealots last stronghold against Rome. We carry on through Ein Gedi to Qumran (Entrance Included) where the Dead Sea Scrolls were discovered. Lunch on your own. This afternoon we enjoy some time at the Dead Sea where you have a float in the mineral rich water. (be sure to bring your bathing suit). Return to Jerusalem for dinner and overnight. (B,D)

Day 10 – Mt of Olives – Mt Zion – Jewish Quarter – Wailing Wall

We begin at the top of the Mount of Olives overlooking Jerusalem. We visit the Chapel of the Ascension (Entrance Included) and celebrate Mass at the Pater Noster Church (Entrance Included), and the Dominus Flevit Church. At the bottom on the Mount of Olives, we visit the Garden of Gethsemane, the Basilica of the Agony, and the Orthodox Tomb of the Blessed Virgin Mary. We then drive to Mount Zion to visit St. Peter in Gallicantu (Entrance Included), the site of the High Priest’s house and the crowing rooster, then to the Cenacle or Upper Room where Jesus shared the Last Supper with His disciples. Here Mary and the Apostles experienced the Holy Spirit at Pentecost. We also visit the Tomb of King David. Enter the Old City for a stroll through the Jewish Quarter seeing the Roman Cardo, Hezekiah’s Wall (Entrance Included) Hurva Synagogue (Entrance Included), life size replica of the Temple Menorah. Nearby is the Temple Institute Museum and the Burnt House excavations which we visit. We reach the Wailing Wall, Judaism’s holiest place for visit and prayers. Tonight’s talk with Rebecca Jackson will be “ Jewish Burial and Wedding Customs”. Dinner and overnight at the Notre Dame de Jerusalem. (B,L,D)

Day 11 – Via Dolorosa – Holy Sepulcher – Departure

Before breakfast, we walk the Stations of the Cross along the Via Dolorosa to the Church of the Holy Sepulcher. Mass is celebrated this morning at the Church of the Holy Sepulcher or at the hotel chapel. Time permitting, we may see the excavations below the Church of the Holy Sepulcher where St. Helen searched for remnants of the True Cross. Return to hotel for breakfast. Rest of the day at leisure. Enjoy a farewell dinner and transfer to airport for your midnight flight. (B, Special dinner) **

Important information regarding your trip:

Group Air:

Select International Tours is a tour company that specializes in group travel. A group is ten or more people traveling together. For each group we negotiate and secure group air contracts with all major airlines departing from the designated airport. This enables us to keep all passengers within a group traveling together, in most cases utilizing best air rates.

Group air contracts differ from individually purchased airline tickets in many ways. When group air contracts are negotiated, we deposit a certain number of seats to hold the space and GTD the rate. Unused seats must be released at least 90 days prior to departure to avoid a \$ 100.00 per unused seat penalty.

It is important to receive your registration by the deadline stated on the flyer. Once the seats are released back to the airlines, we may be able to accommodate passengers at a different air rate or on a different airline.

Group air contracts limit types of deviations allowed and in some cases issuing tickets at individual rates may be necessary. Individual rates & reservations are not GTD until the tickets are issued. In order to issue an individual ticket we must receive full payment. Taxes and fuel costs are subject to change until the tickets are issued.

Domestic add-on tickets:

We can assist you with domestic air to connect with our international group air if you wish. Indicate on the registration form which airport you wish us to research air from. We are not responsible for fees or charges incurred in case dates change or the trip is cancelled. However, when buying a domestic add-on ticket through Select we may be able to assist in case of changes.

We will provide you with best schedule to connect with the flight (we are not able to help you with tickets that do not connect directly to the international flight) and the best price we can offer. Our information will be sent to you by e-mail. We require an acceptance within 24 hours of our offer along with full payment otherwise the rate is subject to change based on availability. We cannot quote any domestic air requests more than twice.

Business Class and Economy Plus Seats:

We are happy to assist you with business class and economy plus seats. Passengers must be registered on one of our trips to receive a quote. We will quote the available rate which is subject to change until we receive payment to purchase the seats. Usually Economy Plus Seats require the group tickets to be issued before the ability to upgrade.

Passport and Visa information:

All airlines require us to submit valid passport information including full name (first, middle and last), date of birth, gender, country, in which your passport has been issued and passport expiration date. To ensure that we can provide this information accurately, we require a photo copy of each person's passport traveling on each tour. Your passport must be valid 6 months from the trip return date. It is the passenger's responsibility to check if visas are required for the destinations visited and to obtain any necessary travel documents. Select International Tours does not provide information or assistance about passports or visa requirements.

Frequent Flyer Numbers:

Select International cannot assist if you wish to reserve air using FF miles. We can update your record with Frequent Flyer #'s only if you note the number on the registration form. Otherwise please call the airline directly.

Seat Requests & Seat Changes

Select International Tours DOES NOT provide assistance with passenger's seating preferences or specific seat requests. Due to the large number of passengers we work with, we are unable to provide this service unless the request is due to a medical issue. In this case, we will request a seat with the airline but cannot guarantee that the seat will be confirmed. Please understand that although requests are being made directly with the airline, not every request is guaranteed or granted by the airline. If you would like to have a seat number assigned, it is best to contact the airline directly upon receipt of your ticket confirmation # or change your seats at the time of check-in at the airport prior to departure.

“Land Only” (not purchasing group air with Select International Tour Package:

We understand that some passengers may wish to purchase their own air transportation. Arranging transportation on your own may give you the ability to use flight miles for your ticket, secure the seat you desire/require, or deviate from the group. We offer land only prices on all our tours.

Airport transfers are not provided for passengers purchasing land only (not purchasing air with us) if arriving or departing at any time different from the group. If you wish to enjoy the benefit of the group transfer, please be sure you are at the airport at the same time as the group. On certain itineraries airport transfers, may be very costly as the group may be traveling a far distance from the airport on the first or last day.

If the flight schedule you purchase arrives or departs at a time different from the group, it is your responsibility to join the group either at the airport or at the first hotel.

If you register for the air and land package and convert to land only, a \$ 100.00 service charge will be assessed should the change be made within 90 days of departure.

Flight cancellations or delays:

In case your flight is cancelled or delayed please work with the airline directly at the airport to be rebooked on the first available flight out. Once you know your new flight and time of arrival contact the emergency number provided in your travel documents to notify your guide of the delay. Your travel documents will contain an emergency number and the guide's phone. Any incurred costs are out of pocket and not included in the trip cost. The cost of private transfers in case of delays are not covered as part of your trip cost. You may file a claim with your Travel Protection Insurance company or with the airlines upon your return. Receipts will be required.

Single rooms:

A limited number of single rooms are available on each trip. If you wish to share a room let us know at the time of registration. We will attempt to connect you with another person looking to share. The cost of Travel Protection insurance will be adjusted to reflect the single supplement as insurance cost depends on total trip cost. Should we not be able to accommodate all single room requests and you are not able or willing to share, a complete refund will be provided.

If your roommate cancels, and the room is converted into single usage, a single supplement will be charged.

How much walking will there be on this trip?

This active program covers a good amount of ground each day. The days are busy, usually starting with a wake-up call around 7AM and departure by 9AM or earlier. We aim to be back at the hotel between 5PM and 6PM. Times may vary depending on destination and program.

Expect from three to four hours walking on some touring days. The pace is moderate, however you will encounter some uneven surfaces, stairs, steps, cobblestones, and significant slopes. Some tours require walking in the open air with no shade and no seating available.

GENERAL LIMITATIONS AND EXCLUSIONS

Insurance benefits are not payable for any loss due to, arising or resulting from: 1. suicide, attempted suicide or any intentionally self-inflicted injury of You, a Traveling Companion, Family Member or Business Partner booked to travel with You, while sane or insane; 2. an act of declared or undeclared war; 3. participating in maneuvers or training exercises of an armed service, except while participating in weekend or summer training for the reserve forces of the United States, including the National Guard; 4. riding or driving in races, or speed or endurance competitions or events; 5. mountaineering (engaging in the sport of scaling mountains generally requiring the use of picks, ropes, or other special equipment); 6. participating as a member of a team in an organized sporting competition; 7. participating in bodily contact sports, skydiving or parachuting, hang gliding or bungee cord jumping; 8. piloting or learning to pilot or acting as a member of the crew of any aircraft; 9. being Intoxicated, or under the influence of any controlled substance unless as administered or prescribed by a Legally Qualified Physician; 10. the commission of or attempt to commit a felony or being engaged in an illegal occupation; 11. normal childbirth or pregnancy (except Complications of Pregnancy) or voluntarily induced abortion; 12. dental treatment (except as coverage is otherwise specifically provided); 13. amounts which exceed the Maximum Benefit Amount for each coverage as shown in the Schedule of Benefits; 14. due to a Pre-Existing Condition, as defined in the Policy. The Company will only pay benefits for Losses occurring within 30 calendar days after the Natural Disaster makes your destination accommodations uninhabitable. Your destination is uninhabitable if: (i) the building structure itself is unstable and there is a risk of collapse in whole or in part; (ii) there is exterior or structural damage allowing elemental intrusion, such as rain, wind, hail, or flood; (iii) immediate safety hazards have yet to be cleared such as debris on roofs or downed electrical lines; or (iv) the rental property is without electricity or water. Benefits are not payable if a storm, snow storm, blizzard or hurricane is named on or before the Effective Date of Your Trip Cancellation coverage;
- e) a documented theft of passports or visas
