

YOUR AGREEMENT WITH SELECT INTERNATINAL TOURS AND CRUISES, INC.

By signing the Registration Page for any one of our trips, your signature or click will signify your agreement with all Terms and Conditions and with this Travel Agreement found on our website:

1. Agent for Suppliers: Select International Tours and Cruises, Inc. ("SITC") acts as a sales agent for any airline, hotel, car-rental company, tour operator, cruise line, or other service provider named in your itinerary or confirmation ("Suppliers"). We are not responsible for the acts or omissions of the Suppliers or their failure to adhere to their own schedules, provide services or refunds, financial default, or failure to honor future trip credits. We have no special knowledge regarding the financial condition of the Suppliers and no liability for recommending a trip credit in lieu of a refund.

2. Risks of Travel and Release: We assume no responsibility for and shall not be liable for the acts or omissions of any party not under our control, or any acts of God, unsafe conditions, terrorism, health hazards including pandemics, illnesses, weather hazards, or the suitability for a disabled person of any portion of any trip. We have no special knowledge of dangers during travel or at destinations. For information related to such dangers, we recommend going to the State Department travel website at www.travel.state.gov, click on "Find International travel Information" then click on "Country Information", and fill in the name of the destination country. For medical and health information, we recommend going to the Centers for Disease Control website at www.cdc.gov/travel, then click on "Destinations" and scroll to the name of the destination country. It is your personal decision to travel, and you are doing so with full knowledge of current travel recommendations and travel restrictions with regards to the risks of COVID-19. YOU HEREBY EXPRESSLY ASSUME ALL OF THESE RISKS AND DANGERS, AND YOU HEREBY EXPRESSLY AGREE TO FOREVER RELEASE, DISCHARGE AND HOLD US, AND OUR AGENTS, EMPLOYEES, OFFICERS, DIRECTORS, ASSOCIATES, AFFILIATED COMPANIES, GUIDES, GROUP LEADERS, AND SUBCONTRACTORS HARMLESS AGAINST ANY AND ALL LIABILITY, ACTIONS, CAUSES OF ACTIONS, SUITS, CLAIMS, AND DEMANDS OF ANY AND EVERY KIND AND NATURE WHATSOEVER WHICH YOU NOW HAVE OR WHICH MAY HEREAFTER ARISE OUT OF OR IN CONNECTION WITH THESE RISKS AND DANGERS.

3. Foreign Entry Rules: You assume full and complete responsibility for checking and verifying any and all passport, visa, vaccination, or other entry requirements of your destination and your connecting points, and all conditions regarding health, safety, security, political stability, and labor or civil unrest at such destination. Many countries require your passport to be valid for six months or more after your date of entry. Some countries will not admit persons convicted of a crime. Some countries require both parents' consent for minors to travel.

4. Cancellation Fees: You agree to pay the travel planning, change, and other trip prices & fees as per the trip brochure and your invoice. Our cancellation terms are disclosed on each trip brochures and will not change regardless of the reason for the cancellation. All of our fees are non-refundable as listed in the trip brochure. the price of a trip after booking, we will try to assist you with rebooking if the Supplier allows it, and a fee may apply. We do not guarantee any refunds or successful rebooking.

5. Price Increases: Trip pricing may change due to exchange rates, additional services requested but not included in the original pricing, number of Travelers traveling on the group departure, airline and government imposed fees, even after you have completed your purchase. You hereby consent to any such price increases and agree to settle any additional charges by check or authorize your credit card to be used for them.

6. Travel Protection: For your protection, we strongly recommend that you purchase Travel Protection (trip cancellation and travel accident insurance). Please note that, unless you buy a Cancel For Any Reason policy, most policies have a specific clause stating they do not cover epidemics and pandemics, acts of war, or terrorist activities (Acts of God), especially when travel warnings are in place. You agree to hold us harmless for your election not to purchase travel insurance or for any denial of claim by travel insurer.

7. Credit Card Merchant: You agree that you will not contest any charges you approved as part of the trip cost and service fees to your credit card and that services provided by Suppliers or disagreement with payment & cancellation terms are not cause to deny credit card charges you original approved and accepted. If the Suppliers do not provide the services, your only recourse would be against the Suppliers, and you agree not to initiate a chargeback against us.

8. Claims Deadline and Exclusive Jurisdiction: You agree to present any claims against us within 30 days after your trip ends and to file suit within one year of the incident, and you acknowledge that this expressly limits the applicable statute of limitations to one year. You agree that the courts in Hunterdon County, New Jersey will be the exclusive jurisdiction for all claims brought by you or us, and you hereby submit to the personal jurisdiction of those courts.
