## ITINERARY

### ✚ July 8, Friday – Day 1: DEPART USA

Depart on an overnight flight from Newark Airport to Budapest. Dinner and breakfast are served on the plane. (D,B)

### ✚ July 9, Saturday – Day 2: ARRIVAL IN BUDAPEST – CRUISE EMBARKATION

Upon arrival in Budapest, we are greeted by our English-speaking tour managers and board our buses for a panoramic tour of Budapest. We drive past City Park, which features Europe's largest medicinal baths, the Budapest Zoo, and Heroes' Square with its statues of the most famous Hungarian kings and dukes. Next we take Andrassy Avenue to downtown Pest, passing by the Opera House and St. Stephen's Basilica. (Our daily program today will depend on flight arrival times.) Mass is celebrated. We then embark on the beautiful Emerald Line deluxe cruise ship, which will be our home for the next seven nights. Settle into your comfortable cabin, unpack and join us tonight for a welcome cocktail reception and orientation in the lounge area, followed by a Hungarian Folklore Show and a wonderful dinner accompanied by local wines. Following dinner, we head out on to the deck to enjoy a Blue Danube Cocktail as the ship takes us on a panoramic Budapest by Night Cruise. Dinner and overnight on cruise. (Welcome Cocktail and Dinner on the ship)

### ✚ July 10, Sunday – Day 3: BUDAPEST: 1000 YEARS OF HISTORY

After breakfast, we head out to explore Budapest, starting at the Chain Bridge and driving over to the Buda side of the city. We stop in the Castle District where, during a short walk, we see the main attractions of the area. We walk to the Matthias Church and Fisherman's Bastion from where we can enjoy the beautiful panorama. Next, we drive to Gellert Hill and the Citadel and see the most spectacular view of Budapest. During our tour, we hear a brief overview of the last 1000 years of Hungarian history. Cross the Elisabeth Bridge to the Pest side where we stop at the Central Market Hall for some souvenir shopping. Mass is celebrated. Return to the cruise ship for a late lunch. In the afternoon, the ship sails for Bratislava. Dinner and overnight on the cruise. (B, Lunch on the ship, D)

### ✚ July 11, Monday – Day 4: BRATISLAVA

We arrive in Bratislava, the capital of the Slovak Republic, in the morning. After breakfast, we have a morning retreat on the ship. Following lunch on the ship, we walk a short distance to celebrate Mass at St. Martin's Cathedral, the coronation site of Hungarian kings. In the afternoon, enjoy time at leisure to explore the city where we find relaxed pedestrian plazas and stylish street cafes. Overnight on the cruise. (B, Lunch on the ship, D)

### ✚ July 12, Tuesday – Day 5: VIENNA: THE ROYAL LIFE AND CLASSICAL MUSIC CONCERT

This morning, we wake up in the beautiful city of Vienna. Following breakfast, we explore Austria's most vibrant city. Enjoy a panoramic drive through Vienna, taking in the world-famous Opera House, Town Hall, Hapsburg Imperial Palace, and more. Walk to St. Stephen's Cathedral, which is in the main square, and see where the Vienna Boys Choir practices and performs. We celebrate Mass at the magnificent Votive Cathedral and have time to explore the city on our own. Be sure to stop by the world-famous Hotel Sacher to try Sacher cake, a not-to-be-missed Viennese treat. You may choose to stay in town for lunch on your own, visit one of the many museums or return to the ship for lunch. In the afternoon, you may wish to tour Schonbrunn Castle (optional - \$ 49.00 per person. Lunch is not included for passengers who choose to take this excursion. Lunch may be purchased on your own in Vienna). Following an early dinner tonight, you may choose to be transferred back to Vienna for a classical music concert (optional \$129.00 per person). Overnight on the cruise. (B, Lunch on the ship, D)

### ✚ July 13, Wednesday – Day 6: WACHAU VALLEY – DURNSTEIN – MELK: A DAY OF WINE AND ABBEYS

This morning at 8:00 AM, we dock in Durnstein, a lovely wine village in the magnificent Wachau Valley, a UNESCO World Heritage Site through which we sail passing lush vine-



yards, fairy tale castles, and ancient monasteries. The perfect little village of Durnstein is in the center of Austria's wine country. You may choose to walk to the town and explore on your own or stay on the ship for a wine seminar just before lunch. Here is an opportunity to hop on a bike for a ride along the Danube, passing through lovely Austrian countryside. The ship will sail and meet you in Melk. Following lunch on the ship, we disembark in Melk for a visit to the beautiful Melk Benedictine Abbey. Our guided tour includes a tour of the Library, the Abbey, and the Church where we celebrate Mass, followed by a visit to a local winery. Enjoy a relaxing dinner on the ship, followed by drinks and music in the lounge. Tonight we gather in the lounge following dinner for Theology on Tap. Overnight on the cruise. (B, Lunch on the ship, D)

### ✠ July 14, Thursday – Day 7: LINZ – SALZBURG – PASSAU: SOUND OF MUSIC

Enjoy an early breakfast before boarding our private motorcoach, which takes us to Salzburg, the city known for the beloved movie "The Sound of Music" and as Mozart's birthplace. Salzburg is enticing with its ornate church towers and grand palaces. The 17th century hilltop shrine overlooking Salzburg has a painting of the Virgin Mary that miraculously survived a bakery fire. The shrine became a Minor Basilica in 1952 and was visited by St. Pope John Paul II in 1983. We have a walking tour of the charming city of music and Mozart. We see the Basilica and stroll along the Getreidegasse to see the house where Mozart was born and take in many familiar sights from the "Sound of Music" movie. Our exploration of the religious heritage of this town includes Nonnberg, believed to be the oldest nunnery in existence, founded by St. Rupert in the 8th century, plus the Benedictine Abbey of St. Peter, also founded by St. Rupert. Wear your most comfortable walking shoes as most of the streets are cobblestone - many closed to vehicles. Enjoy views of 17th century churches and quaint houses. Celebrate Mass at the Shrine of Our Lady of Maria Plain before returning to the ship. We rejoin our ship in Passau and enjoy dinner, followed by music in the lounge. Lunch is on your own today. Overnight on the cruise. (B, Lunch on your own, D)

### ✠ July 15, Friday – Day 8: REGENSBURG: THE CITY OF POPE BENEDICT

After breakfast, we head out to explore this wonderful city. Regensburg is one of Germany's best-preserved medieval cities, famous for sausage-making and the place where Pope Benedict grew up, studied and became a priest. We embark on our city tour of Regensburg, highlighting places visited by the Holy Father in his youth. See the Stone Bridge, St. Peter's Cathedral, the University area, the Castle, and more. Celebrate Mass at the Regensburg Cathedral. Return to the ship for lunch, or choose to stay in the city to enjoy lunch on your own in one of the many local restaurants. Tonight, enjoy a Bavarian Evening on the ship, followed by Captain's Gala farewell dinner. (B, Lunch on the ship, Captain's Gala Dinner)

### ✠ July 16, Saturday – Day 9: NUREMBERG – DISEMBARKATION – ALTÖTTING MARIAN SHRINE

Today we say goodbye to our newfound friends on the ship, board our buses and drive to Altötting Marian Shrine, often called "The Lourdes of Germany" due to the thousands of pilgrims who come here every year in search of healing. Today the shrine attracts over one million pilgrims each year. Many crutches and other votives on display here testify to the healings attributed to the intercession of Our Lady of Altötting. In 1980 St. Pope John Paul II made a pilgrimage here. A young Joseph Ratzinger came here with his father when growing up, and it is known to be one of his favorite shrines long before he became Pope or even a Cardinal. Many young people from Germany make pilgrimages here in the summertime, often walking for 50 miles or more on their journeys. We celebrate Mass and see the "Black Madonna," a wooden statue of the Virgin Mary. Opposite the altar, the hearts of the Bavarian

dukes, kings, and electors are stored in richly decorated silver urns as a special sign of the deep and loyal ties to the Bavarian national Shrine. Among them also is the heart of the fairy tale King Ludwig II. We also visit the Basilica of St. Anna, the Holy Chapel, Collegiate Church, and the treasury, housing the gifts donated to the Basilica. Dinner and overnight in the area. (B.D.)

### ✠July 17, Sunday – Day 10: OBERAMMERGAU PASSION PLAY

Following Mass in Altötting, we drive through the magnificent Bavarian countryside to reach the baroque Weiss Kirche Church. A short drive away is the village of Oberammergau. Today enjoy one of the highlights of our tour, the world-renowned Passion Play, staged every ten years and performed by the local community members. Started 367 years ago, it is still an authentic portrayal depicting the last week of Christ's life. The play takes place on an outdoor stage, and the actors are people from the village who have prepared for their roles for many years. We have time to explore the woodcarver's village and visit the Oberammergau museum before the start of the play in the afternoon. We break for dinner before returning to the theater for the conclusion of the play. Dinner and overnight in the Oberammergau area. (B.L.D.)

### ✠July 18, Monday – Day 11: MUNICH

We depart for the capital of Bavaria, stopping en-route to see Neuschwanstein Castle (outside view) built by King Ludwig, and used as the inspiration for Cinderella's Castle in Disney World. We arrive in Munich for an afternoon walking city tour. Our visits include Frauenkirche (Church of Our Lady), the symbol of Munich, with its towering twin onion-domed steeples. We also see Asamkirche, the most famous church in Munich, and the Marianplatz with its whimsical clock. Mass will be celebrated. Dinner tonight is in one of the famous Beer gardens in Munich. Beer is included as well as a live and authentic oompah band, of course. (B, Special dinner with music)

### ✠July 19, Tuesday- Day 12: MUNICH – USA

We have breakfast and head to the airport for our flight home to the USA. (B)

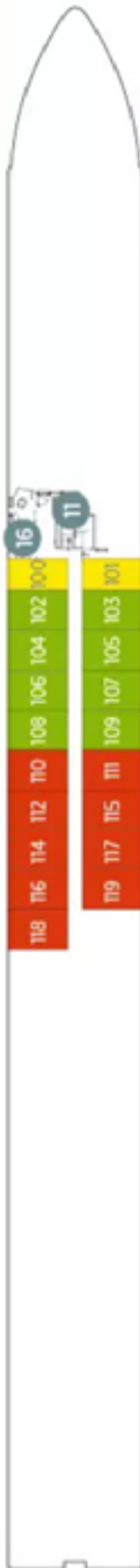

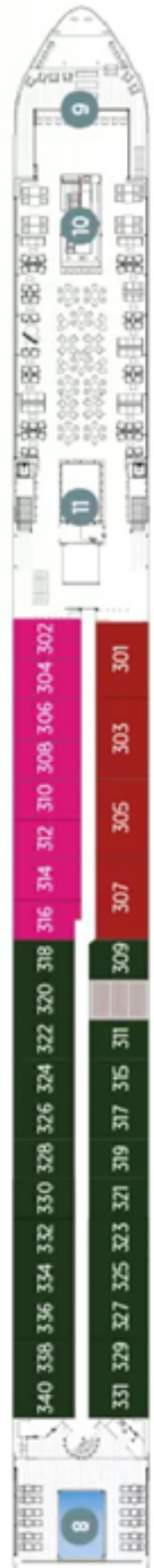

## Rules and Regulations

**Deposits and final payment:** A **deposit of \$1,500.00** per person by check should accompany the registration form along with your optional travel protection payment, if purchasing, and a copy of your passport picture page by **January 8, 2022. A second deposit of \$1,500.00 is due February 23, 2022. Final payment is due by April 9, 2022.** Please mail your payment to: **Select International Tours, 85 Park Ave., Flemington, NJ 08822 Attn: Susan Prendergast, 800-842-4842, susan@select-intl.com.**

**Your passport must be valid through January 19, 2023. Reservations will not be processed until we have passport copies.** Prices quoted are based on cash payments.

**Pilgrimage prices:** Prices are based on minimum 140 passengers. Prices may be adjusted in the event of fewer than 140 passengers, changes in currency conversion rates, or amendments in local government taxes and/or fuel surcharges. Prices are in US dollars. For European travel an exchange rate of US \$1.16 per Euro is assumed.

**Tour Cancellation Policy:** **\$1,000.00 per person non-refundable up until 180 days before departure. 180-120 days, a total of \$1,500.00 per person is non-refundable. Within 120 days of departure all payments are non-refundable regardless of reason for cancellations.** All cancellations must be in writing. Unused portions of the trip are not refundable. If a roommate cancels, the cost of a solo supplement will be added to your invoice. You may be eligible for a refund through your travel protection. Refer to the U.S. Policy by State on our website. We strongly encourage you to purchase **Travel Protection**. Call or visit our website for details on the cost per person for the Group Deluxe and Cancel For Any Reason (CFAR) plans. CFAR is not available in NY State. We encourage all travelers to purchase a plan at the time of initial deposit. This document contains highlights of the plans. The plans contain insurance benefits underwritten by the United States Fire Insurance Company. The plans also contain non-insurance Travel Assistance Services that are provided by an independent organization. Coverages may vary and not all coverage is available in all jurisdictions. **Airline, seating and special requests:** To best accommodate our pilgrims, we often utilize Group Air Reservations. These allow more predictable transfer and tour schedules. However, when booking Group Air, the airline (not Select International Tours) controls seating assignments. If you require very specific seats, we suggest that you book your own airfare and take advantage of our “Land Only” options. You may communicate directly with the airline to request seating changes, provide mileage program information, or change passenger contact information once you receive ticket numbers—approximately three (3) weeks prior to departure. We work with instant purchase airline tickets and or group rates. If you switch from air and land to land only within 90 days from departure you will be charged a \$100 service fee in addition to any airline charges. All special

needs and requests due to medical or dietary restrictions must be requested in writing at least 60 days prior to departure. Business class and Premium Coach seats are available upon written request; as are add-ons from your hometown airport. If you require very specific airlines or schedules, we suggest that you book your own airfare and take advantage of our “Land Only” options.

**Walking:** Our trips require daily walking, sometimes up or down slopes, steps, and uneven terrain. We recommend preparing oneself, by walking before the trip. Anyone needing assistance is required to be accompanied by a qualified and physically-able travel companion. We are not responsible for any medical condition that occurs prior, during or after the trip.

**Safety Procedures:** Select International Tours has undertaken a reasonable inquiry, with all the suppliers (including airlines, hotels, bus companies and other service providers) used on our trips to ensure they have instigated the best available procedures regarding the pandemic- protective policies advised by local government and health authorities. ## **Important information regarding your trip:**

### **Group Air:**

Select International Tours is a tour company that specializes in group travel. A group is ten or more people traveling together. For each group we negotiate and secure group air contracts with all major airlines departing from the designated airport. This enables us to keep all passengers within a group traveling together, in most cases utilizing best air rates.

Group air contracts differ from individually purchased airline tickets in many ways. When group air contracts are negotiated, we deposit a certain number of seats to hold the space and GTD the rate. Unused seats must be released at least 90 days prior to departure to avoid a \$ 100.00 per unused seat penalty.

It is important to receive your registration by the deadline stated on the flyer. Once the seats are released back to the airlines, we may be able to accommodate passengers at a different air rate or on a different airline.

Group air contracts limit types of deviations allowed and in some cases issuing tickets at individual rates may be necessary. Individual rates & reservations are not GTD until the tickets are issued. In order to issue an individual ticket we must receive full payment. Taxes and fuel costs are subject to change until the tickets are issued.

### **Domestic add-on tickets:**

We can assist you with domestic air to connect with our international group air if you wish. Indicate on the registration form which airport you wish us to research air from. We are not responsible for fees or charges incurred in case dates change or the trip is cancelled. However, when buying a domestic add-on ticket through Select we may be able to assist in case of changes.

We will provide you with best schedule to connect with the flight (we are not able to help you with tickets that do not connect directly to the international flight) and the best price we can offer. Our information will be sent to you by e-mail. We require an acceptance within 24 hours of our offer along with full payment otherwise the rate is subject to change based on availability. We cannot quote any domestic air requests more than twice.

### **Business Class and Economy Plus Seats:**

We are happy to assist you with business class and economy plus seats. Passengers must be registered on one of our trips to receive a quote. We will quote the available rate which is subject to change until we receive payment to purchase the seats. Usually Economy Plus Seats require the group tickets to be issued before the ability to upgrade.



**Passport and Visa information:**

All airlines require us to submit valid passport information including full name (first, middle and last), date of birth, gender, country, in which your passport has been issued and passport expiration date. To ensure that we can provide this information accurately, we require a photo copy of each person's passport traveling on each tour. Your passport must be valid 6 months from the trip return date. It is the passenger's responsibility to check if visas are required for the destinations visited and to obtain any necessary travel documents. Select International Tours does not provide information or assistance about passports or visa requirements.

**Frequent Flyer Numbers:**

Select International cannot assist if you wish to reserve air using FF miles. We can update your record with Frequent Flyer #'s only if you note the number on the registration form. Otherwise please call the airline directly.

**Seat Requests & Seat Changes**

Select International Tours DOES NOT provide assistance with passenger's seating preferences or specific seat requests. Due to the large number of passengers we work with, we are unable to provide this service unless the request is due to a medical issue. In this case, we will request a seat with the airline but cannot guarantee that the seat will be confirmed. Please understand that although requests are being made directly with the airline, not every request is guaranteed or granted by the airline. If you would like to have a seat number assigned, it is best to contact the airline directly upon receipt of your ticket confirmation # or change your seats at the time of check-in at the airport prior to departure.

**“Land Only” (not purchasing group air with Select International Tour Package:**

We understand that some passengers may wish to purchase their own air transportation. Arranging transportation on your own may give you the ability to use flight miles for your ticket, secure the seat you desire/require, or deviate from the group. We offer land only prices on all our tours.

Airport transfers are not provided for passengers purchasing land only (not purchasing air with us) if arriving or departing at any time different from the group. If you wish to enjoy the benefit of the group transfer, please be sure you are at the airport at the same time as the group. On certain itineraries airport transfers, may be very costly as the group may be traveling a far distance from the airport on the first or last day.

If the flight schedule you purchase arrives or departs at a time different from the group, it is your responsibility to join the group either at the airport or at the first hotel.

If you register for the air and land package and convert to land only, a \$ 100.00 service charge will be assessed should the change be made within 90 days of departure.

**Flight cancellations or delays:**

In case your flight is cancelled or delayed please work with the airline directly at the airport to be rebooked on the first available flight out. Once you know your new flight and time of arrival contact the emergency number provided in your travel documents to notify your guide of the delay. Your travel documents will contain an emergency number and the guide's phone. Any incurred costs are out of pocket and not included in the trip cost. The cost of private transfers in case of delays are not covered as part of your trip cost. You may file a claim with your Travel Protection Insurance company or with the airlines upon your return. Receipts will be required.

**Single rooms:**

A limited number of single rooms are available on each trip. If you wish to share a room let us know at the time of registration. We will attempt to connect you with another person looking to share. The cost of Travel Protection insurance will be adjusted to reflect the single supplement as insurance cost depends on total trip cost. **How much walking will there be on this trip?**
